Specifications Invitation for Bid Heating Oil

The Westhampton Selectboard is accepting bids for #2 heating oil and burner service for the town buildings for the 2016-2017 heating season.

The buildings and estimated quantities needed are as follows:

Bidders are asked to submit bids for both fixed and variable prices. Automatic delivery is required, with change to "will call" status an option by request of the Town. If a bid for a pre-paid fixed price contract is submitted and accepted, any unused balance must be refunded at the expiration of the contract.

The successful bidder must also be able to provide complete burner services as well as 24 hour emergency service as needed for all town buildings served under this contract. Bids should include an hourly rate for fuel burner service as well as information on a service contract. The decision on the service contract would be left to each department individually, separate from the fuel oil award.

Bids must be received by 7:00 p.m. on Monday August 22, 2016 and must be in a sealed envelope clearly marked "Heating Oil Bid."

Executed Certificate of Non-Collusion and Tax Compliance Certification must be submitted with the bid. Forms are attached.

The contract will be awarded to the responsive and responsible bidder offering the lowest price. The award will be made that evening. The Town may cancel this IFB, or reject in whole or in part any and all bids, if the Town determines that cancellation or rejection serves the best interests of the Town.
