# MINUTES of an EXECUTIVE SESSION

Tuesday, October 11, 2022, at 7:00 PM

The Westhampton Selectboard scheduled a regular meeting to be held on Tuesday, October 11, 2022, at 7:00 PM at the Town Offices, 1 South Road, and via video-conference.<sup>1</sup>

#### Call to Order

The meeting was called to order at 7 PM by Phil Dowling, Chair.

#### **Executive Session**

#### Ongoing Litigation

Mr. Finn noted that, due to an appeal of a Special Permit Decision, made by the Zoning Board of Appeals, the original applicant had requested to withdraw their Special Permit application, stating their desire to discontinue their defense of the decision. Town's Counsel requested permission to allow the appealant to receive summary judgment, which would annul the original decision, and require all parties to be responsible for their own costs and fees.

After review and discussion, it was MOVED by Dowling, SECONDED by Johndrow

To agree to the recommendation of Counsel, and to file no objection to summary judgment on behalf of the plaintiff in the case.
