Ryan Nelson (Wetland/Soil Scientist), Levesque Associates, Inc., on behalf of Saltmarsh presents plans/NOI documents: portion of driveway remains within riverfront area; however, alterations include installation of culvert, erosion controls, silt fencing; proposed septic system ok; property owners provided appropriate responses to Mark Stinson's questions/concerns (in documents): Cons Com will draft and sign OOC and send copies to property owners, etc.to submit to Hall of Records, etc.; Cons Com will visit site at some point during construction after silt fences are constructed; After completion, Cons Com will complete and submit COC.

Sue Tracy Small, on behalf of HRSD: culvert existent for 30 years without issue; completely blown out; recommends repair/reset/adjustment to culvert, add fill from Public Safety Complex, maintain site more regularly; Because it is a perennial stream on private property, a NOI will be required;

Melissa Nuttelman presents photos and documents showing necessary structural repair to Pickerel Rock Diving Dock, not chemically treated, rot resistant, black locust; Cons Com approves repairs as routine maintenance/repair;

Leah Stanton: she has concerns about knotweed/invasive, non-native species by Sodom Brook; help with removal?; community service project for students?; will contact science teachers at HRHS for support;
