Upon review of deliberations and salaries from last meeting (4/19) a motion was made to:

* increase Line 4 to recommend \$4238.00	Vote: 8-0-0
* increase Line 10 to recommend \$8019.00	Vote: 8-0-0

New Business

Chief White clarified the need for \$2000 to cover mandated training. A motion was made to re-enter \$2,000.00 dollars from free cash into Line 55 making the recommended amount \$53,935.00. Vote: 8-0-0

Memorial Day A motion was made to return \$200.00 to Line 47. Vote: 8-0-0

Painting Town Hall A motion was made to "negate" the prior vote to make Line 132 contingent on override. Vote: 8-0-0 A motion was made to "delete" Line 123 and increase Line 132 to \$30,000.00 Vote: 8-0-0

Chief Norris requested that the Fire Department Multi-Gas Meter funds be incorporated in the overall budget for the Fire Department. A motion was made to "drop" \$5,000.00 from Line 106 and add those funds into Line 58 bringing the recommended total to \$42.200.00. Vote: 7-0-1

A motion was made to recommend Line 57 be funded at \$441.00 Vote: 8-0-0

Vocational Tuition

After learning new information from Joe B., a motion was made to recommend Line 38 at \$360,710.00. Vote: 8-0-0

A motion was made to:

*increase Line 69 to recommend \$700.00.*reduce Line 63 to recommend \$1375.00.

Vote: 8-0-0

Joe Boudreau shared that the HRHS Budget will allow \$37,000.00 to be placed in Free Cash.
