- 1. Call to Order: 7:19 pm
- 2. Minutes: Reviewed, unanimously accepted.
- 3. Treasurer's Report: Library Gift Account: \$22,533.89; Building Account: \$8,625.36; Public Libraries Fund: \$0; State Aid: \$1,533.32; Deferred Town Monies: \$6,084.83. Total of \$38,777.40. (corrections: State Aid Account: \$0. Deferred Town Monies \$86,084.83 for a Grand Total of \$177,244.08).
- 4. Director's Report: Update on automatic door: it is fixed. Suggestion is made that parents be encouraged not to let children play with the door to extend its utility. The new outdoor light is installed. Mikki Nevins should write thankyou note to Wade Clement for donating his time and expertise with the door and light.

Final budget is intact, one last Verizon bill will be submitted. With extra money we did AC, Septic, outside light.

Last: Suggestion that we get some kind of virus protection for the computers. Gingras will get a price and will let us know how much it would be to protect our four public computers.

Dempsey asks if it was acceptable to put a note on the door when Gingras was delayed with a sprained leg: we agreed yes.
