THE COMMONWEALTH OF MASSACHUSETTS TOWN OF WESTHAMPTON ANNUAL TOWN MEETING MAY 14, 2022

Agreeable to the foregoing warrant and with a quorum of approximately 60 present at Town Hall, Moderator Ben Warren called the meeting to order at 9:11am. Thanks were extended to those who donated to the improvements in the Hall: The floors were sanded, repaired and refinished by Mike Labrecque and crew. The walls, wainscoting, doors and trim were prepped and painted by Phil Dowling with assistance from Maureen Dempsey. The windows were prepped and painted by Pat and Joe Coffey and Adam Golash. Wade Clement and crew installed the projector and screen. Peter and Mary Montague donated a podium for the Moderator. It was noted that the warrant had been clarified by dividing the budget article into multiple articles by category and that the meeting handout provided further clarity by listing line items within those articles. Thanks were extended to Douglas Finn, Administrative Assistant, for the handout and for the projection of this information on the new screen during the meeting. The following articles were then acted upon:

ARTICLE 1: It was voted unanimously to accept all reports presented at said meeting.

The Annual Town Report was available and oral reports were presented for Zoning By-Law Review Committee and Capital Planning Committee.

ARTICLE 3: It was voted unanimously to authorize the Selectboard to take care of the highways, including entering into contracts, and accepting any money from the Commonwealth of Massachusetts or other sources.

ARTICLE 4: It was voted unanimously to authorize the Selectboard to apply for and expend grants from federal or state programs.

ARTICLE 5: It was voted unanimously to amend the general bylaw of the Town of Westhampton, Article 5 "The Finance Committee", by adding section 5-4-4 as follows:

5-4-4 The Town shall establish and maintain the following revolving funds in accordance with Section 53E-1/2 of Chapter 44 of the General Laws:

5-4-4-1 - For the purchase of Fire Department materials, supplies and training, to be funded by inspection fees, and to be expended without further appropriation by the Fire Chief.

5-4-4-2 – For the maintenance, upkeep and groundskeeping of the Westhampton Cemetery, to be funded by sales of plots and burial fees, and to be expended without further appropriation by the Cemetery Superintendent.

ARTICLE 6: It was voted unanimously to authorize or re-authorize the following Revolving Funds for the purposes and amounts as listed below.

ARTICLE 28: It was voted by a majority to appropriate the sum of One Hundred Eighty Four Thousand, Three Hundred Seventy Six Dollars (\$184,376), as may be certified from available funds, due to the Town as Chapter 90 Highway funds from the Transportation Bond Issue.

ARTICLE 29: It was voted by a majority to transfer from Free Cash the sum of Two Thousand Nine Hundred Twenty Five Dollars (\$2,925) exactly, for an Actuary Report on the OPEB costs and liability for the fiscal year ending June 30, 2023.

ARTICLE 30: It was voted by a majority to transfer from Free Cash the sum of Two Hundred Twenty Thousand Dollars (\$220,000) exactly, for the purpose of purchasing a utility tractor with articulating brush mower deck, and other requested and necessary equipment and additions, for use by the Westhampton Highway Department.

ARTICLE 31: It was voted unanimously to transfer from Free Cash the sum of Twenty Nine Thousand Dollars (\$29,000) exactly, for the purpose of purchasing of a Trailer Mounted Compressor, for use by the Westhampton Highway Department.

(Articles 32 & 33 generated much discussion as to funding source. It was explained that although ARPA funds had been used to pre-order these vehicles, the intention of the Selectboard had always been to request funding from Town Meeting.)

ARTICLE 32: It was voted by a majority to transfer from Free Cash the sum of Seventy Six Thousand Dollars (\$76,000) exactly, for the purpose of purchasing a new medium-duty four-wheel-drive truck with necessary and requested upfit additions, for use by the Westhampton Highway Department.

ARTICLE 33: It was voted by a majority to transfer from Free Cash the sum of Sixty Five Thousand Dollars (\$65,000) exactly, for the purpose of purchasing a new light- or medium-duty four-wheel-drive truck with necessary and requested upfit additions, for use by the Westhampton Police Department.

ARTICLE 34: It was voted by a majority to transfer from Free Cash the sum of Seven Thousand Five Hundred Dollars (\$7,500) exactly, for the purchase of upgrades to radios and other communication equipment, for use by the Westhampton Police Department.

ARTICLE 35: It was voted by a majority to transfer the sum of One Hundred Sixty Thousand Dollars (\$160,000) exactly, from Free Cash to the Stabilization Fund.

(An amendment to reduce the amount to \$25,000 failed but generated much discussion on general budgeting, the use of Free Cash and impacts on the tax rate.)

ARTICLE 36: It was voted unanimously as amended to transfer the sum of Ninety Six Thousand, Nine Hundred Fifty Two Dollars (\$96,952) exactly from Free Cash to balance the budget and reduce the tax rate for the Fiscal Year 2023.

It was voted unanimously at 11:34 am to adjourn this meeting to Saturday, June 4, 2022 at 8 o'clock AM, at the Town Hall, 1 South Road, at which time and place the polls will be open until 12 o'clock Noon for the election of town officers under Article 2 of the warrant for this meeting, and that upon the announcement of the results of the election, this meeting be dissolved.
